APPROVAL OF EXPENDITURES – Bills in the Amount of \$3,729,537.00 including SCWRF Project Pay Request #16 for \$1,507,723.84 – Mr. Boyle stated Gerber Construction has submitted Pay Request #16 for \$1,507,723.84 (\$1,587,077.73 less \$79,353.89 retainage of 5%). Work includes: installed RAS splitter troughs and gates in Solids Building, installed structural steel roof members in Solids Building, continued masonry rake walls on Headworks Building, continued formwork and pouring concrete for the Bioreactors' walls, continued slabs and walls in Tertiary Filter Building, continued installing drain piping and slabs on west side of the Electrical Building, finished installing shingles on Operations Building, and continued laying process piping around the EQ Basins, Solids Building, and Bioreactors.

The work is 45.80% complete. The time elapsed is 37.67%.

Ms. Pack made the motion to approve the Expenditures, Mr. Richer seconded and the motion carried with Ms. Pack, Mr. Richer and Mr. Wilking voting in the affirmative.

V. SUBDIVISION PROJECTS

A. Silver Creek Village Lot 13 – 49 REs

A Line Extension Agreement has been filed to extend wastewater main lines into Lot 13 of Silver Creek Village. The proposed main lines will connect to lines that are currently under construction as part of the Silver Creek Village Phase 1A project.

Staff recommends approval.
