4. ULGT Premium Relief Credit 2019 – Trust Premium Relief Program – \$3,782.00 credit to District. The Trust Board of Directors recently approved a \$1,000,000 Premium Relief Credit for members. The amount of this premium credit ranges from 0% to 7% of our liability premium and 0% to 7% of our workers compensation premium. Our credit is based on our performance and longevity with the Trust. Our credit amount is 7% of our 2019 liability premium and 7% of our 2019 workers compensation premium.
