VII. DISTRICT MANAGER

A. Discussion Items

1. COVID 19 Update – Mr. Luers stated that the governor keeps pushing back essential workers for the COVID 19 vaccine. He said he is continuing to work with the Health Department on getting us on the list for the vaccine.

Mr. Joyce stated that the good news is that things are picking up and hopefully we would get the vaccine available soon.

2. Fraud Risk Assessment Implementation – Mr. Luers asked Mr. Passey to address the Board. Mr. Passey stated that the Utah State auditor now requires Districts to complete a Fraud Risk Assessment Questionnaire, to be reviewed and discussed with the Board of Trustees each year. We rated 320 out of 395. Our rating was in the low category.

Mr. Pick asked about getting us to the very low category. Mr. Passey said he believes we can get there.

3. Department of Homeland Security – Cyber Remote Penetrating Test Results – Mr. Luers asked Mr. Tackman to brief the Board regarding the Cyber Remote Penetrating Test Results.

Mr. Tackman said the CISA Assessments team identified the following findings as potentially exploitable vulnerabilities that could compromise the confidentiality, integrity, and availability of the tested environment. Each finding includes a description, supporting details, and recommended steps for mitigation. The following findings are presented for review, validation, and remediation as deemed appropriate. The SBWRD team reviewed the findings and recommendations for technical weaknesses, shortcomings in processes and procedures, and systemic weaknesses in overall security posture. Additional information from testing and on each specific finding is collected during the RPT, and the entire store of raw data was provided to the SBWRD POC at the conclusion of the test. When appropriate, findings may refer to information available within the raw data. The raw data includes a "README" file with details on the setup of the data store.

Mr. Tackman reviewed the results of the assessment and said we are in good shape overall.

Mr. Joyce asked what is it that we fear?

Mr. Luers stated that in essence cyber criminals could shut down the system.

1. Updated Asset Management Plan – Mr. Luers told the Board that each year we review our Asset Management Plan. The Board of Trustees sets a level of service to our customers and we do what it takes to deliver that service. The heart and soul of this plan is to maintain the infrastructure so you don't have failures and emergency breakdowns, and don't have sewage running down the road.

We follow the International Infrastructure Managers Manual that was actually put together by Australia and New Zealand, and you might ask why did they put it together? Back in the late eighties and nineties they had some horrific breakdowns of the wastewater system and their Federal Government requires all water and wastewater facilities to maintain infrastructure at a certain level. That is something the United States has not done and that is why you see failing systems though out the United States. There is no Federal guidelines to maintain Infrastructure in the US. It cost a whole lot less money to maintain it than it does to fix it.

Mr. Luers stated that this one of the biggest and most important decisions the Board can make. He asked the Board to consider approving the Updated Asset Management Plan.

Mr. Joyce made the motion to approve the Updated Asset Management Plan, Ms. Pack seconded the motion carried with Mr. Pick, Mr. Richer, Mr. Joyce and Ms. Pack voting in the affirmative.

2. 2020 Annual Infrastructure Asset Report – Mr. Luers discussed the 2020 Annual Infrastructure Asset Report. He said that this report is the District's annual report card. Mr. Luers gave kudos to the staff. He asked the Board to approve the Annual Infrastructure Asset Report.
